1. Call to Order

The meeting was called to order at 9:01 a.m. by Committee Vice Chairman Oakden.

2. Pledge of Allegiance

The Pledge of Allegiance was led by Committee Member Gomes.

3. Review and Adoption of the Agenda

A <u>motion</u> was made by Committee Member Gomes to approve the May 19, 2022 O&M Committee Meeting Agenda, seconded by Committee Member Jardine, request for comment, and the motion was unanimously approved.

4. Public Comment

No public comment.

5. <u>Miscellaneous Correspondence</u>

No miscellaneous correspondence.

6. General Manager & Staff Reports

• Rusty Jardine, General Manager

Rusty Jardine, General Manager reported that the Repayment Contract for Extraordinary Maintenance (XM) on the Truckee Canal will include a term of fifty (50) years. Also, an XM Project pre-bid site visit is scheduled for May 26, 2022. Jardine will provide a presentation on water issues to the Subcommittee on Public Lands next week.

Cody Biggs, Construction & Maintenance Manager

Cody Biggs, Construction & Maintenance Manager reported that a crew was repairing a drain crossing on Jackrabbit Road under the S-22. In addition, two (2) employees are finishing Commercial Drivers' License (CDL) School and will test in July. Crews are cleaning drains and monitoring moss.

Mark Solinski, Hydroelectric Manager

Mark Solinski, Hydroelectric Manager reported on current power production at all three (3) Power Plants, maintenance problems at Old and New Lahontan and difficulties obtaining materials for the tower gates.

Kelly Herwick, District Water Master

Kelly Herwick, District Water Master provided the attached report (Exhibit A) detailing current conditions and the forecast. Discussion followed.

Mike Adams, Systems & Technologies Manager

Mike Adams, Systems & Technologies Manager reported that the GOES grant project is progressing; the mobile measurement device trailer has been constructed and meter measurements have been taken; the District will assume security responsibility of the Derby Dam Fish Screen building; Derby Dam Fish Screen SCADA restored, though not in auto mode.

7. Conservation Work Order Review

There were no comments on the Conservation Work Order Review.

8. Damage Claims Submitted

Damage Claim 22-001: Request for replacement of materials lost due to a haystack fire at 7000 Curry Road, submitted by Aaron C. Williams.

Damage date: 04/20/2022

Damage location: east of E1 canal

Damage cause: fire

Damaged property: hay, fencing and water trough liner

Discussion included:

- o High fuel loads; specifically tumbleweeds
- District crews required to burn ditch and pull trash from ditch to facilitate water delivery
- Jardine provided guidance regarding negligence as a basis for damage claim
- Review of District map and photos taken by the District and Williams relative to source of fire and resulting damage
- Review of District crews recollection of events
- Wind as a contributing factor relative to cause of damage

A <u>motion</u> was made by Committee Member Gomes to recommend denial of damage claim, seconded by Committee Member Biggs, request for comment, and the motion was unanimously approved.

9. Incidents & Accidents

No incidents or accidents reported.

10. New Applications Received

No new applications received.

11. <u>U.S. Fish & Wildlife Service Representative(s)</u>

Not present to report. Kelly Herwick, District Water Master reported that USFWS had requested that flows be increased on the L terminus. Herwick will inquire if a new management plan will be submitted.

12. Fallon Paiute Shoshone Tribe Representative(s)

Rob Martinez, Bureau of Reclamation, reported that the Bureau, the District and the Fallon Paiute Shoshone Tribe (FPST) met on May 11th to discuss mapping of the Reservation. Martinez also reported that FPST submitted a letter of support for the Truckee Canal Extraordinary Maintenance funding application. Herwick reported that the FPST is ordering water for new seeding on the Reservation and has picked up additional farming land off the Reservation. Jardine commented on water scheduling in accordance with the Memorandum of Agreement (MOA). Leanna Hale, Land & Water Manager reported FPST is pleased with the communication relative to monthly meetings, a walk through on the S7-3 project will be conducted on June 1st and the FPST is pursuing engineering for the S Line Reservoir lining project.

13. Naval Air Station Fallon (NASF) Representative(s)

Not present to report.

14. Nevada Department of Wildlife (NDOW) Representative(s)

Not present to report. Rob Martinez, Bureaus of Reclamation stated that Nevada Department of Wildlife (NDOW) is working on a water ordering scheduling plan for the Carson Lake Pasture (CLP). Martinez also reported that Isaac Metcalf and Jake Ward attended water measurement training. Herwick provided an update regarding proposed water measurement devices for the CLP; Gomes commented on accuracy of measurement due to the moss.

15. Bureau of Reclamation Representative(s)

Rob Martinez, Bureau of Reclamation, provided an update on the Fernley takeout, submission of 3-Year OM&R Work Forecast and Standard Operating Procedures (SOP) in accordance with Exhibit G of the OM&R Contract, and the urban canal inspection scheduled for June 8 and 9.

A <u>motion</u> was made by Committee Member/General Manager Jardine to approve the minutes from the February 17, 2022 Committee meeting, seconded by Committee Member Gomes, request for comment and the motion was unanimously approved.
