1. Call to Order

Vice-President Stix called the meeting to order in accordance with NRS 241 at 9:00 a.m.

2. <u>Pledge of Allegiance</u>

The Pledge of Allegiance was led by Director Gomes.

3. Approval of the Agenda

A <u>motion</u> was made by Director Gomes to adopt the agenda as presented, seconded by Director Schank, request for comment and the motion was unanimously approved.

4. General Public Comment

Mr. David Serrahn addressed the Board and offered his apology to the members of the O&M Committee; at the previous O&M Committee meeting he made comments that were taken as threatening and that was not his intention. He requested that his appeal of the O&M Committee's decision (Item # 15) be withdrawn.

5. <u>Miscellaneous Correspondence</u>

Shawcroft reported on the correspondence received during the month of September.

6. General Manager and Staff Reports

Ben Shawcroft, General Manager

Shawcroft reported that the District has begun taking water orders for the Truckee Division. An issue has arisen regarding the City of Fernley's lease water program; no paperwork was filed this spring for lessees as there was no season anticipated. The District is willing to deliver the lease water in an effort to ensure that everyone able to accept delivery is accommodated; paperwork just needs to be filed with the City of Fernley and sent to the District office. He will be conducting a tour of Lahontan Dam this afternoon with Melanie Brooks who is visiting from New Zealand.

Cody Biggs, Construction & Maintenance Manager

Biggs reported that the RO&M repair of the Truckee Canal liner at Painted Rock will be finished this week. Crews are working in the Truckee Division mowing and burning ditches to prepare for the upcoming season. Rodent holes will be grouted in approximately two weeks. In the Carson Division crews are working on Trouble Calls as they come in.

Kelly Herwick, District Water Master

Herwick reported on current conditions in the Carson Division. See the attached report. There is a crew of ditchriders working in Fernley burning ditches and making sure everything is prepped and ready. Storage in Lake Lahontan at the end of the season is expected to be approximately 220,000 AF.

• Mike Adams, Systems & Technologies Manager Adams was not present to report.

• Mark Solinski, Hydroelectric Facilities Manager Solinski reported the energy plant production below. The SCADA system at 26' Drop needs to be replaced.

7. <u>City of Fernley – General Updates</u>

Neal McIntyre, Mayor – City of Fernley (City), commented that in his new capacity as Mayor of Fernley he was unaware that the District had reserved time during monthly Board meetings for updates from the City. He will ensure that a representative is present going forward. McIntyre commented on efforts the City is expending to find federal financial relief for well owners in Fernley.

8. United States Fish & Wildlife Service (USFWS) – General Updates

Bethany Chagnon, Deputy Manager – Stillwater Wildlife Refuge, commented that they are moving water north in the Refuge to prepare for the winter season and in anticipation of additional water being delivered in the spring. Hunting season opens in two weeks.

9. <u>Bureau of Reclamation – Lahontan Basin Area Office (LBAO) Representative(s) –</u> <u>General Updates</u>

Robert Martinez, Newlands Project Coordinator, reported that meetings are ongoing and that progress is being made on the Truckee Canal Public Safety Project.

- 10. <u>Fallon-Paiute Shoshone Tribe (FPST) General Updates</u> Leanna Hale, Land & Water Resource Director, was present but had no report.
- 11. <u>Naval Air Station Fallon (NASF) General Updates</u> There was no representative present to report.
- 12. <u>Natural Resources Conservation Service (NRCS) General Updates</u> There was no representative present to report.
- **13.** <u>Nevada Department of Wildlife (NDOW) General Updates</u> There was no representative present to report.

14. Use of Fernley Stockwater Outside Irrigation Season

At the Board meeting held on September 5, 2023, a discussion was held on the delivery of stockwater outside of the irrigation season in the Truckee Division that is scheduled to conclude 30 days following the start of deliveries on or near the 1st day of November. The Board will receive a recommendation from the General Manager and take possible action on the request to maintain a charged Truckee Canal for purposes of delivering stockwater.

Shawcroft informed the Board of his research into the stockwater question; he has reviewed the language in the Decrees and discussed the matter with the Federal Water Master, Ernie Schank and Rusty Jardine. The conclusion reached by all parties is that keeping the Truckee Canal charged to serve the stockwater lines is in violation of the Decree. Mr. Jardine was drafting a policy before his retirement to adopt this practice, Shawcroft will be bringing the matter before the Policy Committee in the future to consider adopting it as a standard policy. At this time, Shawcroft does not recommend maintaining a charged Truckee Canal for purposes of delivering stockwater.

15. <u>Appeal of O&M Committee Denial of Damage Claim by David Serrahn</u>

Deliberation and decision pertaining to the appeal of the O&M Committee decision regarding the Damage Claim in the amount of \$1,500.80 submitted by David Serrahn.
