Pursuant to Nevada's Open Meeting Law, Notice is Hereby Given that the Truckee-Carson Irrigation District Carson Lake Pasture Committee will hold a Meeting on Wednesday, February 10, 2021 at the Hour of 6:00 p.m.

This meeting will be held via teleconference only. Pursuant to Governor Sisolak's March 22, 2020 Declaration of Emergency Directive 006, the requirement contained in NRS 241.023(1)(b), that there be a physical location designated for the meetings of public bodies, where the public are permitted to attend and participate, is suspended in order to mitigate the possible exposure or transmission of COVID-19 (Corona Virus). Accordingly, any person planning to participate in the meeting must do so by using the teleconference number.

All meetings of the Committee for the Truckee-Carson Irrigation District (TCID or the District) are public (NRS 539.093). This agenda is a tentative meeting schedule. Action will be taken on all items unless otherwise noted. While meetings of the Committee are subject to Nevada Open Meeting Law (NRS 241.010 et. Seq.) (OML), no provision of the OML requires the Committee to discuss or take action on all agenda items. The Committee may hear items in a different order, combine items for consideration or remove an item from the agenda or delay discussion relating to any item at any time to accomplish business of the Committee, on behalf of the electors of TCID, in the most efficient manner. Items scheduled at a specific time will not be heard earlier than at the scheduled time pursuant to the OML. Except in an emergency, TCID will provide written notice of its meetings consisting of a clear and complete statement of the topics scheduled to be considered. No action may be taken on any matter that is not scheduled on this agenda. Any statement made by a member of TCID during a public meeting is absolutely privileged and does not impose liability for defamation or constitute a ground for recovery in any civil action. Meetings of the Committee may be conducted according to the rules of parliamentary procedure.

The Committee may recess the meeting in order to convene an attorney-client meeting.

The Committee may take possible action on any item on this agenda unless that item is marked "For Information Only." Items marked "For Information Only" may be discussed by the Committee after any presentation is made but no action may be taken on that particular item. The Committee may take items out of order, may combine two or more agenda items for consideration, may remove items from the agenda or may delay discussion of any item at any time.

6. **Carson Lake Pasture Grazing Operations for the 2021 Grazing Season**

Deliberation and decision relating to formulation of recommendations to be developed by the Carson Lake Pasture (Pasture) Committee, for approval by the Board of Directors of the Truckee-Carson Irrigation District, relating to the terms and conditions of use relating to the Pasture, by authorized Pasture Grazers, in the 2021 Grazing Season. Terms and conditions of use will include any contractual obligations to be imposed by the State of Nevada, as record owner of the Carson Lake and Pasture, relating to management of public lands, to be imposed by virtue of transfer of ownership of lands by the United States to the State of Nevada in the year 2021. Such terms and conditions to include, without limitation, application processes relating to issuance of grazing permits, the amount of fees to be imposed, a determination of persons to be permitted entry into the Pasture in 2021, the total number of animal units permitted, the beginning and end times for grazing, authorized entry and facility locking, and any collateral considerations, or limitations that may impact grazing practice –such as hunting on State lands.

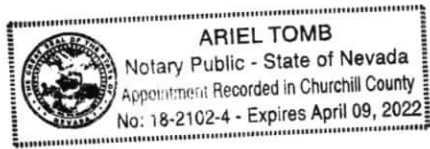
