

FARM SERVICE AGENCY FUNDING APPLICATION

Instructions: Please read all instructions carefully prior to filling out this application.

1. TCID is requesting applications from producers in the Carson Division to become eligible to receive funding from the Farm Service Agency (FSA) for an on-farm project that will conserve water. TCID will select 1-3 projects that will be awarded a grant. Applications will be ranked based on the quantity of water saved, project cost, constructability, and overall ability of applicant to comply with all contract requirements. No matching funds will be required from the applicant.
2. Examples of eligible projects include, but are not limited to - ditch lining, piping, leveling of fields, installation of water saving technology, etc.
3. Fill out the form and deliver to the TCID office or email to ariel@tcid.org no later than **4:30 pm on November 15, 2024**. Late applications will not be considered. Please contact the office if you need assistance at (775) 423-2141.
4. Payments cannot be made for a practice for which the applicant has already received funds or is contracted to receive funds through any other USDA program.
5. Multiple applications for the same farm operation will not be considered.
6. An eligible applicant must establish, or have already established, farm records with the FSA (have farm, tract, and field numbers in place) and meet Highly Erodible Land Conservation and Wetland Conservation requirements.
7. Projects will not be required to be submitted to NRCS for review.
8. The successful applicant(s) will be required to enter into a contract with TCID that satisfies all FSA requirements under this program.
9. Any water conserved as a result of the completed project(s) will remain under the ownership of the water right owner and will not be subject to forfeiture, retirement, or abandonment by participating in this program.
10. TCID reserves the right to select any project(s) that fit within the overall goals and allowable budget of this funding program.
