#### 1. Call to Order

Vice- President Stix called the meeting to order in accordance with NRS 241 at 9:00 a.m.

## 2. Pledge of Allegiance

The Pledge of Allegiance was led by Director Workman.

## 3. Approval of the Agenda

A <u>motion</u> was made by Director Gomes to adopt the agenda as presented, seconded by Treasurer deBraga, request for comment and the motion was unanimously approved.

## 4. General Public Comment

Ida Adams and Juanita George addressed the Board with a reminder for the upcoming election in April; Directors in divisions One, Three and Four are up for re-election.

## 5. <u>Miscellaneous Correspondence</u>

Vice-President Stix informed the Board that the District received a very nice letter from an individual in Fernley expressing thanks for getting the water turned back on.

## 6. General Manager and Staff Reports

## Ben Shawcroft, General Manager

Shawcroft reported that he is working on end of year reports and a contract for the purchase of hydro power. Work on amending the 5 Year Strategic Plan is ongoing; he is expecting to have it finished in time for the next meeting.

## • Cody Biggs, Construction & Maintenance Manager

Biggs reported the concrete crew is working on the A15 and A15-1. The tree crew is on the V4 for another two weeks, then will be moving to the S-Line and R-Head. Cleaning the Carson River channel began today.

## Mark Solinski, Hydroelectric Facilities Manager

Solinski reported the bowl at Old Lahontan was pumped out and cleaned. Next week he will be taking measurements for the new runners at 26' Drop. Both Old and New Lahontan are ready to run.

## 8. United States Fish & Wildlife Service (USFWS) – General Updates

Carl Lunderstadt, Refuge Manager – Stillwater National Wildlife Refuge, was present but had no report.

# 9. <u>Bureau of Reclamation – Lahontan Basin Area Office (LBAO) Representative(s) – General Updates</u>

Jack Worsley, Area Manager, reported that the Truckee Canal contractor will be back on site next week to finish covering the last 300' of liner. A Risk Assessment Team is scheduled to inspect the Canal in late January. There have been some changes at the Bureau regional office; Carl Stock is the new Regional Director replacing Ernest Conant who retired.

## 10. Fallon-Paiute Shoshone Tribe (FPST) - General Updates

## 12. Natural Resources Conservation Service (NRCS) - General Updates

## 13. Nevada Department of Wildlife (NDOW) - General Updates

Jacob Ward, Wildlife Technician, reported he will be attending training until February 9<sup>th</sup> so the person to contact during that time will be Isaac Metcalf. Hunting season has been slow.

### 14. Preparation of Annual Assessment Book

Deliberation and decision relating to preparation and approval of the annual assessment book created by the District Assessor, Robert Oakden, Board Secretary, containing a full and accurate description of all land in the District, and a list of the persons who own, claim or have possession or control thereof, during the year, giving the number of acres listed to each person as provided for by NRS 539.667.

Secretary Oakden commented that a copy of the Assessment Book was available for anyone who wished to review it.

A <u>motion</u> was made by Secretary Oakden to approve the Annual Assessment Book, seconded by Director Gomes, request for comment and the motion was unanimously approved.

# 15. <u>Approval of the Proposal by Truckee Donner Public Utilities District for the</u> Purchase of Hydroelectric Power

Deliberation and decision regarding approval of a contract with the Truckee Donner Public Utilities District for the sale of hydroelectric power generated by TCID. The proposal is for TCID to sell the hydropower and related energy credits at the rate of \$46.50 per MWh for a term of 2 years and an option to renew for an additional 3 years. The TCID Revenue Committee has reviewed the proposal and is recommending approval of the contract.

This item was tabled until the February meeting.

# 16. <u>Grant Award R22AC00022 Truckee-Carson Irrigation District for Airborne Snow</u> Observatory Driven Forecasting in the Truckee-Carson Basins

Truckee Conson engation District Regular Sension Meeting Minutes January 2, 2024 Page 3 of 5 Deliberation and decision approving an assistance agreement with the Bureau of Reclamation for a grant being awarded to TCID for Airborne Snow Observatory Driven Forecasting in the Truckee-Carson Basins. The forecasting provided by these flights is valuable to TCID in managing the spring runoff.

General Manager Shawcroft provided the Board with an overview of the grant. This will provide \$3 million to fund the Airborne Snow Observatory (ASO) flights that the District relies on data from. There is no cost to the District to accept this grant.

A <u>motion</u> was made by Treasurer deBraga to approve an assistance agreement for Grant Award R22AC00022, seconded by Secretary Oakden, request for comment and the motion was unanimously approved.

17. Appeal of O&M Committee Denial of Damage Claim by LaDawn Graham

Deliberation and decision pertaining to the appeal of the O&M Committee decision regarding the Damage Claim in the amount of \$23,465.00 submitted by LaDawn Graham.

Ms. Graham was not present for the meeting. General Manager Shawcroft provided the Board an overview of her claim and the reasons the O&M Committee denied it.

A <u>motion</u> was made by Secretary Oakden to deny the appeal of the Damage Claim submitted by LaDawn Graham, seconded by Director Gomes, request for comment and the motion was unanimously approved.

#### Carson Lake Pasture Grazing Management Contract

Deliberation and decision by the Board of Directors relating to approval of recommendations associated with the contract for management of grazing (also known as the "Cowboy Contract") for the 2024 season at the Carson Lake Pasture, in Churchill County, Nevada, by and between the Truckee-Carson

Irrigation District and Holt Bogdanowicz - as an independent contractor. Terms and conditions of the contract include, without limitation, the rate of compensation (\$39,226.00), term, reciprocal duties and expectations relating to pasture management.

Treasurer deBraga reported the Committee reviewed three applications and voted to recommend Holt Bogdanowicz for the position of Pasture Manager.

A <u>motion</u> was made by Treasurer deBraga to approve the Carson Lake Pasture Grazing Management Contract with Holt Bogdanowicz, seconded by Director Workman, request for comment and the motion was unanimously approved.
