3. Review and Adoption of the Agenda

A <u>motion</u> was made by Committee Member Gomes to approve the agenda, seconded by Committee Member Washburn, request for comment and the motion was unanimously approved.

4. Public Comment

5. Carson Lake Pasture Manager

Deliberation and decision relating to the formation of a recommendation to the Board of Directors as to the selection of a candidate to serve as the next Carson Lake Pasture manager.

The Committee interviewed the following candidates to determine their suitability for the position of Pasture Manager:

- Cody deGolyer Cody has 30 years' experience running his own business as a
 horse trainer, running rodeo cows, and was a correctional officer for 7 years. He
 works well by himself or with others, knows how to fix fences, and has
 experience presenting to Boards and Committees. He does not have a lot of
 experience irrigating but is confident that he could learn guickly.
- Holt Bogdanowicz Holt grew up riding horses & moving cows, he owns 5
 horses and has experience irrigating. He has worked for ranches in Washoe
 County, has management experience and experience working heavy equipment
 and mending fences. He is comfortable making recommendations related to
 feed availability. He currently works in the maintenance department at DFA with
 a rotating schedule.
- Lee Barkdull Lee has worked at the District for 28 years, he also worked for NV Cattle breeders. He doesn't have any horses currently but could get one, he has no experience irrigating, and he is comfortable making recommendations relating to feed availability and where cattle should be grazing.

The Committee discussed the possibility of electing a manager amongst themselves rather than hiring one, as communication and availability have been an issue in the past. Mike Zahradka, Nevada Department of Wildlife, commented that he would be more comfortable with a dedicated pasture manager rather than a grazer. Carson Lake Pasture policy also states that the Pasture Manager is not permitted to run his own cattle. The Committee consensus was to choose a candidate today and further explore alternative options at a later meeting when more grazers are present.

A <u>motion</u> was made by Committee Member Lee to recommend Holt Bogdanowicz to the Board for the position of Pasture Manager, seconded by Committee Member Washburn, request for comment and the motion was unanimously approved.

6. Nomination of a New Grazer Representative to sit on the Carson Lake Pasture Advisory Committee

Deliberation and decision relating to selection of a Grazer representative to sit on the Carson Lake Pasture Advisory Committee.

Jerilynn Guazzini nominated Kenny Lee for the grazer representative.

A <u>motion</u> was made by Committee Member Gomes to approve the agenda, seconded by Committee Member Snodgrass, request for comment and the motion was unanimously approved.
