## THE AGENDA

#### Notes:

For the purposes of this agenda, words which appear in **bold face** are intended only for ease of reference in the creation of this agenda. The full description of the agenda item, to be deliberated upon and decided by the Truckee-Carson Irrigation District (District) Contract Negotiations Committee, (Committee) if at all, follows the words appearing in **bold face**.

All meetings of the Truckee-Carson Irrigation District Contract Negotiations Committee are public (NRS 539.093). This agenda is a tentative meeting schedule. Action will be taken on all items unless otherwise noted. While meetings of the Committee are subject to Nevada Open Meeting Law (NRS 241.010 et. Seq.) (OML), no provision of the OML requires the Committee to discuss or take action on all agenda items. The Committee may hear items in a different order, combine items for consideration or remove an item from the agenda or delay discussion relating to any item at any time to accomplish business of the Committee, on behalf of the electors of the District, in the most efficient manner. Items scheduled at a specific time will not be heard earlier than at the scheduled time pursuant to the OML. Except in an emergency, the District will provide written notice of its meetings consisting of a clear and complete statement of the topics scheduled to be considered. No action may be taken on any matter that is not scheduled on this agenda. Any statement made by a member of the District during a public meeting is absolutely privileged and does not impose liability for defamation or constitute a ground for recovery in any civil action. Meetings of the Committee may be conducted according to the rules of parliamentary procedure.

The Committee may recess the meeting in order to convene an attorney-client meeting.

The Truckee-Carson Irrigation District Contract Negotiations Committee may take possible action on any item on this agenda unless that item is marked "For Information Only." Items marked "For Information Only" may be discussed by the Committee after any presentation is made, but no action may be taken on that particular item. The Committee may take items out of order, may combine two or more agenda items for consideration, may remove items from the agenda or may delay discussion of any item at any time.

The recommendations by the Committee, relating to a proposal to enter into contract for the Extraordinary Maintenance (XM) on the Truckee Canal, and subsequent approval by the Board of Directors and electors of the District, when implemented, do not alter or impair the water rights of water right holders bearing vested and

perfected Truckee River and/or Carson River water rights in the Project pursuant to either the Alpine Decree or Orr Ditch Decree or other water rights established by the State of Nevada.

The Project, means the federal reclamation project in the vicinity of Fernley and Fallon, Nevada, authorized pursuant to the Reclamation Act of June 17, 1902, (32 Stat. 388) as amended.

The Truckee-Carson Irrigation District has operated the Project since December 18, 1926. The Project consists of major water delivery features in both the Carson River and Truckee River basins, including, without limitation, Derby Diversion Dam, Truckee Canal, Lahontan Dam, Carson River Diversion Dam, Lahontan Power Plant, V-Line Canal, and hundreds of miles of delivery canals, laterals, drainage features, and diversion structures.

Negotiations commenced on May 13, 2022 and will continue as needed or may be needed. Public notice of such meetings will be provided at a later date.

5. **Two-Party Negotiation for Terms of an Agreement for Repayment of Monies, Relating to Construction Performed for Extraordinary Maintenance to the Truckee Canal, Within the Fernley Reach of the Canal, in the Newlands Federal Reclamation Project, Nevada, by and Between the Negotiations Committee of the Truckee Carson Irrigation District and**

**the United States of America, Department of the Interior, by and Through the Bureau of Reclamation**

Deliberation and Decision by the Truckee-Carson Irrigation District Negotiations Committee, of the Truckee-Carson Irrigation District, and the United States of America, Department of the Interior, by the Bureau of Reclamation, Lahontan Basin Area Office, for development of recommendations to be made for presentation to the Board of Directors, for its later consideration and approval, as to the terms of an agreement for repayment to the United States for monies made available for infrastructure related improvements pursuant to the Bipartisan Infrastructure Bill of 2021, consisting specifically of repair to be made to the Truckee Canal in the Fernley Reach thereof, in Fernley, Nevada. Contract terms to be considered, include, without limitation, the scope of repairs to be made to the Canal –such as lining, replacement of the Fernley Check structure, armoring of “Pour Point Eight,” near the bridge at U.S. Highway 95, and modification to the Bango Check Structure, the repayment principal amount, contract length or term, rate of interest, and other special conditions that may or shall attend repayment processes. Final approval of a repayment contract must be made by the electors of the District pursuant to NRS 539.297.

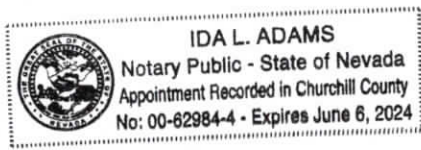
