Lahontan Solar LLC (formerly SLR Solar) Proposal for Leasehold of District 5. Owned Lands

Deliberation relating to creation of a recommendation to the Board of Directors for their final approval regarding a proposal by Lahontan Solar LLC (formerly SLR Solar) for leasehold of a portion of District owned lands within Assessor's Parcel Number 007-011-22. This property is located to the north of Bango Road and west of U.S. Highway 50 in Churchill County, Nevada. This proposal contemplates development of a solar facility upon District lands capable of 25 Megawatts of electric energy production.

Discussion highlights include the following:

- Review of the "Land Business Term Sheet" provided for Committee consideration
- The Lahontan Solar LLC proposal includes the lease of 120 acres with expected production of 25 megawatts with the expectation of expanding the project to include the lease of 500 acres with expected production of 100 megawatts
- Proposed location of the solar facility on the parcel considering topography and access routes; the southwest corner and the northeast corner of the parcel were considered most suitable
- Feasibility for expansion of transmission lines
- The permitting process associated with the solar project
- Request for review of lease agreement for Committee consideration
- Request by the Committee for Lahontan Solar LLC to consider leasing 380 acres of the total 500 acres for a reduced rate

A follow-up meeting will be scheduled in July.
